** Breaks are built into the class time.

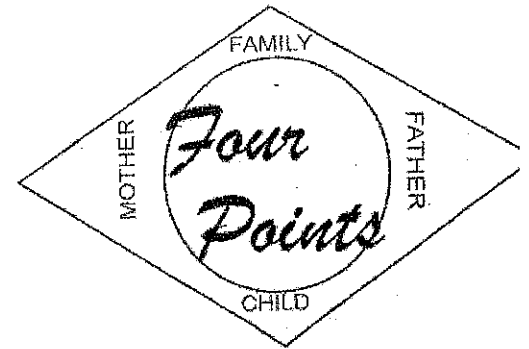
Directions

* Walker County Annex: 108 Villanow St. LaFayette GA 30728. Hwy. 27 to LaFayette. Located on the corner of Duke and Villanow Sts. The building houses Veteran's Affairs.

* Catoosa County Library: 108 Catoosa Circle, Ringgold GA 30736. Take Hwy. 2/Battlefield Pkwy. Turn onto Old Mill Rd. Look for CVS and Colonnade sign. Turn right onto Catoosa Circle. The Library is on the left.

* Dade County Commissioner's Rm.: 71 Case Ave. Trenton GA 30752 Take I-75, Hwy. 136 or Hwy. 11 to Trenton. The Room is on the 2nd floor and next door to the Justice Building (Sheriff's Dept.)

* Chattooga County Annex: 120 Cox St. Summerville GA 30747. Take Hwy. 27 to Summerville. Turn west onto Washington St. at the main courthouse. The building is on the left across from the Sheriff's Dept. The class is in the small courtroom.

About TransParenting™

TransParenting™ is an educational program designed to teach effective parenting during the transitions of divorce and parental separation. This is an educational program and NOT a counseling session. Parents will not be expected to discuss personal issues.

The seminar emphasizes each parent's responsibility to provide a nurturing, non-threatening environment for the child.

Topics include:

- * Feelings associated with divorce.
- * Ways that children of different ages react during transition.
- * A parenting approach that will benefit your children.
- * Suggested ways for talking to children about divorce.
- * Other adjustments children will need to make.

The course is taught by professionals who have experience with children and who have been specially trained by the program creator and owner, Families First, to teach the class.

Attendance

Attendance at the class is required for all parties to a case where the interests of children under the age of **18** years are involved. The court's action will not be delayed by a non-moving party's refusal or delay in completing the class.
